

# **MESSAGE FROM THE CHAIR**



### **COMMITTEE REPORTS** Audit, Finance and Investment Committee Report Chair: Andrew Beckett

Market Value of the Endowment Fund as of March 31: 2019: \$9,593,686 2020: \$11,232,297 2021: \$17,107,044

The Endowment Fund investments were negatively impacted by the COVID-19 pandemic in February and March of 2020. Since that time, our investments have fully recovered. During the 2021 fiscal year, \$1.8 million was added due to new donations. The balance of the increase in the Fund, \$4,074,747, was due to investment returns. The Fund's One Year Return on Investments was 34.7% (2020: -12%) compared to the custom benchmark return of 27.2%.

In the Fall of 2020, the Foundation issued a Request for Proposals to select an investment consultant that could provide the Foundation with a full range of administrative and investment services. CIBC Wood Gundy were selected, and all investments were transferred to them in early 2021.

To guide the investment process, the Foundation Board has adopted a detailed Investment Policy Statement. As part of this Policy Statement, the following Asset Mix was established:

Reflecting on this past year, one word comes to mind – **community.** Time and time again our Foundation community has stepped up and this past year was no different.



2020-21 was a year we'll never forget but not for the reasons you're thinking! This year the Foundation hit a major milestone in our endowment campaign-hitting \$19 million in pledges of our \$20 million dollar campaign goal. We committed over \$700,000 towards the purchase of new equipment for St. Martha's and held some incredible events, despite the COVID-19 pandemic!

Hitting \$19 million dollars in pledged donations is a big deal! We're thrilled and taking us up to that \$19 million dollar mark was a \$500,000 pledge from the Sisters of St. Martha. I want to extend a special thank you to the Sisters of St. Martha for this incredible donation and for their examples of humanity, hope and generosity. They have left a legacy at St. Martha's that we work to preserve every day. A legacy we will work hard to carry on; one that works to provide the hospital staff and physicians with the best tools to care for the residents of the quad-counties. We will continue the work that they began with perseverance and passion.

This year the Foundation committed over \$700,000 towards the purchase of new and innovative equipment for St. Martha's Regional Hospital. Your donations supported the purchase a new portable ultrasound machine for the Ophthalmology department; cardiorespiratory enhancements for the echo machine in the Sobey Foundation Cardiorespiratory Unit, which allowed healthcare teams to provide services that patients previously had to drive to Halifax or Truro to access; high-fidelity humanoid mannequins and task trainers to support COVID-19 preparedness; and, a cardiac doppler for the operating room, just to name a few.

This year we held community sessions on planned giving including a quick pivot to video-conferencing sessions to meet public health COVID-19

restrictions. We held our annual Chip in Fore St. Martha's Golf Tournament and had a record-breaking year for Hospital Help Day, raising just over \$91,000!


